

## MEMBERSHIP CATEGORIES

### Accredited Member - AIHM and FIHM

Those who have earned either their AIHM or FIHM designation are accredited members of the Institute. AIHM and FIHM members have completed the education requirement and they have also attained the experience necessary. FIHM is a special designation bestowed on those who have contributed significantly to the profession and to the Institute. Accredited members receive complimentary registration for IHM virtual events and a reduced fee for the Annual Educational Conference as well as access to the Members' Only section of the website. AIHM and FIHM members have voting rights.

### Honourary Candidate - AIHM (C)

The AIHM(C) designation is available to those who have completed the education requirement but who have not yet fulfilled the experience necessary. AIHM(C) members have applied for and been approved for this designation. AIHM(C) members receive complimentary registration for IHM virtual events and a reduced fee for the Annual Educational Conference as well as access to the Members' Only section of the website. AIHM(C) members do not have voting rights.

### Candidate Member
